# SUMMARY ANNUAL REPORT FOR ABBINGTON MANAGEMENT CORP. GROUP MEDICAL PLAN

This is a summary of the annual report of the Abbington Management Corp. Group Medical Plan, a health plan (Employer Identification Number 31-1454490, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Abbington Management Corp. has committed itself to pay certain Medical claims incurred under the terms of the plan.

## **Insurance Information**

The plan has insurance contracts with Everest Reinsurance Company and Optum Health to pay certain Stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$226,804.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was -\$12,149 as of the end of plan year, compared to \$2,531 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$14,680. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$664,449 including employer contributions of \$608,973, employee contributions of \$55,358 and earnings from investments of \$118. Plan expenses were \$679,129. These expenses included \$25,465 in administrative expenses, \$334,598 in benefits paid to participants and beneficiaries, and \$256,316 in other expenses.
